- A. Treasurer Christina Celeste, checking \$145,683.94, savings \$5,792.26 total \$151,476.20. (M) Vicky Wingfield (S) Jennifer Hanshew (C) Christina reminded chapters that insurance payments are due, still have three chapters from last fiscal year and a few from this year. Also need to turn in reports as needed by the deadlines.

Tony also shared that there is a group Instructors and Drivers in the Yuba City / Marysville area a group that was formed for Roadeo that has some money that they have been trying to give back to the school district and they don't want it so they want to donate a little over \$600.00 to CASTO. In the Executive board meeting it was decided is to use that money to help both Yuba City USD and Marysville USD become agency members. This will allow all their drivers and employees become members and also motivate them to continue next year with the agency memberships. We hope to keep them for a long time.

- D. Special Representatives -
  - 1. California Department of Education Anna Borges Anna wanted to start with she had received a letter from the International Roadeo they wanted to take a brief survey, 1,

They wanted to know it we as an organization be hosting a Roadeo for 2021? 2. Then would we be sending them to Milwaukee? They are trying to figure out whether they should be preparing for an International Road. Maybe She, Doug and Tony should meet for further discussion. The governor is meeting today to go over his budget. He has set aside \$2,000,000.00 to support safety measures. He came out with his plan for children to return to school. You can go on the governor's website for details. Its quite a lengthy document explaining how and why we need to return to school, to resume some type of normalize. Its been tough times but we have tough leaders in our industry, that's all of you. It takes all of us to remain positive move forward and know that we can achieve getting our kids back to school on the safest mode of transportation, which is the school bus, with all of your direction, drivers, instructors, dispatcher, mechanics. Its been tough but we will overcome and continue to move forward. About the Office of School Transportation, we are cancelling the January and April classes. At this point we are still not able to congregate with that many people yet. They are receiving an email as we speak cancelling the class and moving them to the next available class, which is January will be moved to June, April will be moved to July. When we can resume, we will schedule classes back to back to assist the industry. The two classes we were just discussing are full and we have been receiving Delegate Behind the Wheel application, which is another question, we are not able to travel anywhere to conduct evaluation for Delegates Behind the Wheel as well. When the ban is lifted, we will take it head on get it done. As we discussed at the last Board meeting, we are working on doing some virtual training courses, we are finalizing that right now. We will be running an Administration program maybe mid-February, a Special Needs virtual training, which is a two-day program. We are also going to bring back on certain days a one-day virtual trainings, which will be for state certified Instructors. We have five different programs, Loading and Unloading, Dual Air Brake System, Documentation and a few other. Everybody is working remotely including the downtown office. The extension for Special Certificates is extended until 2/28/2021. Believe we will receive another extension at the end of February.

- 3. Contractors Representative Erin Borda not much to report, just waiting for the green light to open, very worried about the small driver situation. A challenge to get drivers to work the longer this goes on our industry is facing a server driver shortage. If we don't reopen fully in LA County until August, the new school year, it will be a full 18 months that drivers have been not been working. The Contractors like the Districts we have been working to stay connected with the drivers keeping up their hours, doing renewals but its frankly I'm worried it's going to be messy if we don't open soon.
- 4. CASBO Representative Matt Sanchez not available today sent Tony an email. CASBO is looking to professionally record programs for Conference, so more details to come this month.

So now we are looking into how much is cost to get gmail, the purpose behind this is because we can't sign into Zoom with our district email accounts because we have district Zoom accounts, we need to have separate email accounts for google for CASTO.
